## Author Guidelines

### General

Please read the instructions below for brief details on the Journal's requirements for manuscripts. Manuscripts in an incorrect format may be returned to the author.

### Manuscript Submission

Submissions are now made online using ScholarOne Manuscripts (formerly Manuscript Central). To submit to the journal go to <http://mc.manuscriptcentral.com/jarid>. If this is the first time you have used the system you will be asked to register by clicking on 'create an account'. Full instructions on making your submission are provided. You should receive an acknowledgement within a few minutes. Thereafter, the system will keep you informed of the process of your submission through refereeing, any revisions that are required and a final decision.

### Manuscript Format and Structure

All manuscripts submitted to *JOURNAL OF APPLIED RESEARCH IN INTELLECTUAL DISABILITIES* should include:

**Cover Page:** A cover page should contain only the title, thereby facilitating anonymous reviewing. The author's details should be supplied on a separate page and include postal address, telephone and fax numbers as well as an email address. The author for correspondence should be identified clearly.

**Running Title:** A short title of not more than fifty characters, including spaces should also be provided.

**Keywords:** Up to six keywords to aid indexing should be provided.

**Main Text:** All papers should be divided into a structured abstract (150 words) and the main text with appropriate sub headings. A structured abstract should be given at the beginning of each article, incorporating the following headings: Background, Materials and Methods, Results, Conclusions. These should outline the questions investigated, the design, essential findings and main conclusions of the study. The text should then proceed through the sections of Introduction, Materials and Methods, Results and Discussion, and finally Tables. Figures should be submitted as a separate file.

**Style:** Manuscripts should be formatted with a wide margin and double spaced. Include all parts of the text of the paper in a single file, but do not embed figures. Please note the following points which will help us to process your manuscript successfully:

- include all figure legends, and tables with their legends if available;
- do not use the carriage return (enter) at the end of lines within a paragraph;
- turn the hyphenation option off;
- in the cover email, specify any special characters used to represent non-keyboard characters;
- take care not to use l (ell) for 1 (one), O (capital o) for 0 (zero) or ß (German esszett) for (beta);
- use a tab, not spaces, to separate data points in tables; if you use a table editor function, ensure that each data point is contained within a unique cell, i.e. do not use carriage returns within cells.

**Original Articles, Review Articles, Brief Reports, Book Reviews and Letters to the Editor** are accepted.

**Theoretical papers** are also considered provided the implications for therapeutic action or enhancing quality of life are clear. Both quantitative and qualitative methodologies are welcomed. All original and review articles continue to undergo a rigorous, peer-refereeing process.

Articles are accepted for publication only at the discretion of the Editor. Articles should not exceed 7000 words. Brief Reports should

not normally exceed 2000 words. Submissions for the Letters to the Editor section should be no more than 750 words in length.

### References

Spellings should conform to *The Concise Oxford Dictionary of Current English* and units of measurements, symbols and abbreviations with those in *Units, Symbols and Abbreviations* (1977). For further details please see the journal webpage <http://wileyonlinelibrary.com/journal/jar>.

### Tables, Figures and Figure Legends

Tables should include only essential data. Each table must be type-written on a separate sheet and should be numbered consecutively with Arabic numerals, e.g. Table 1, and given a short caption.

Figures should be referred to in the text as Figures using Arabic numbers, e.g. Fig. 1, Fig. 2, etc, in order of appearance. Figures should be clearly labeled with the name of the first author, and the appropriate number. Each figure should have a separate legend; these should be grouped on a separate page at the end of the manuscript. All symbols and abbreviations should be clearly explained.
