New research project

Palliative Care for persons with intellectual and multiple disabilities, PiCarDi

Catholic University of Applied Sciences NRW Dep. of Social Siences | Munster, Germany

Background: Persons with PMID are up to now underrepresented in palliative care services in Germany. The research project explores the situation both in palliative and disability services with a special view on the service users and their relatives. The multi-perspective design includes data collection, semi-structured interviews with experts, service users and relatives, focus group discussions with service users and concepts of person-centred planning. Participatory research is guaranteed by a supervisory board of service users. The results of a initial secondary analysis of existing data show, that the number of persons with ID dying in residential homes is increasing. The death rate in the analyzed group in this setting is 18.8 (ner

thousand), while the death rate in the general adult population in Germany is 13,4. But still, professional capacity in many cases does not yet meet special needs of persons with PMID in end-of-life care sufficiently. Group discussions with persons with ID on the other hand show quite clear concepts of dying and wishes according to adequate support in this vulnerable situation. All in all, crossing network lines between the support systems seems to be crucial for adequate capacity building, Pedagogical expertise is needed to ensure participation esp. for persons with profound and multiple disabilities, which is a core subject corresponding to the human rights in the end of life. We would like to invite you to complete a questionnaire about assessment in people with Profound Intellectual and Multiple Disabilities (PIMD) Assessment is defined in this study as: The systematic collection, ordering and interpretation of information about a person and his or her situation, to obtain an adequate representation of the person (De Bruyn, Ruijssenaars, Pameijer, & van Aarle, 2009). Policy and practice of healthcare delivery to persons with profound intellectual and multiple disabilities by unregistered assistive personnel in foreign countries

We compared practices of the delivery of four kinds of healthcare to persons with profound intellectual and multiple

disabilities by unregistered assistive

personnel (UAP) among nine countries including Japan. We then compared the policies for healthcare delivery via support workers in four countries including Japan. Airway suctioning, tube feeding, inhalation and nebulization and tracheal suctioning were delivered by UAP, although the kinds of healthcare delivered by each paid UAP category differed among the countries Parents delivered the aforementioned healthcare in nine countries, except for tracheal suctioning, which was forbidden in three countries. Four countries required UAP to obtain additional licenses for delivering healthcare. Finding UAP for healthcare delivery was difficult in three countries. Regarding policies for delivering healthcare via support workers, training and supervision of UAP by registered nurses (RN) was required in all countries studied except for Japan, and more kinds of healthcare were delivered by UAP in these countries than in Japan. Comparing practices among those countries was difficult because of the differing healthcare systems in each country. However, this comparison revealed the importance of revising and improving Japan's UAP healthcare delivery policy by adding training and supervision by visiting RN, as well as developing a policy for decreasing the burden of these RN.
